CONNECTICUT GENERAL ASSEMBLY

The Human Services Committee will be holding a public hearing on Tuesday, February 21, 2023 concerning H.B. No. 6618 - An Act Concerning Medical Assistance for Certain Persons Receiving Abortion Care and Related Services In Connecticut.

The stated purpose of the bill is to provide state-administered medical assistance for certain outof-state residents receiving abortion care and related services in Connecticut. In other words, Planned Parenthood, which has a billion dollar a year budget, wants to encourage pregnant women living in pro-life states to come to pro-abortion Connecticut to kill their unborn babies by having you, and other Connecticut taxpayers, pay for their Medicaid abortions. Corporate welfare?

According to a recent article in the Waterbury Republican American newspaper, Governor Lamont is also proposing a \$2 million state fund to provide abortion services for residents of other states that limit abortions. The proposed fund would also pay for transportation, lodging and other costs relating to abortion care and contraceptives.

In the meantime, your gasoline tax will be increasing again, and money to go for abortions for women from out-of-state, could instead be spent for Connecticut's residents' astronomical home heating oil bills, veteran's benefits, the homeless, or to help pregnant women who live in Connecticut to keep and support their newborn children.

Contact your state senator and state representatives and tell them to vote "NO" on HB 6618 and against any funding in the budget for abortions for out-of-state women!

The following bills concerning abortion have been introduced.

Please contact your legislators to encourage them to <u>SUPPORT</u> the following bills that would require parental notification for abortion.

HB05190 - AN ACT REQUIRING PARENTAL NOTIFICATION PRIOR TO THE TERMINATION OF A PREGNANCY BY A MINOR.

HB05358 - AN ACT REQUIRING PARENTAL NOTIFICATION PRIOR TO THE TERMINATION OF A PREGNANCY BY A MINOR.

HB05900 - AN ACT REQUIRING PARENTAL NOTIFICATION OF THE PROVISION OF ANY MEDICAL OR MENTAL HEALTH SERVICE TO A MINOR.

SB00536 - AN ACT REQUIRING PARENTAL NOTIFICATION PRIOR TO THE TERMINATION OF A PREGNANCY BY A MINOR.

Ask them to <u>OPPOSE</u> the following bills that would make abortion a state constitutional right.

HJ00008 - RESOLUTION PROPOSING A CONSTITUTIONAL AMENDMENT TO PROTECT THE RIGHT TO AN ABORTION.

HJ00018 - RESOLUTION PROPOSING AN AMENDMENT TO THE STATE CONSTITUTION TO RECOGNIZE A RIGHT TO TERMINATE A PREGNANCY.

Ask them to <u>OPPOSE</u> any bills, such as those below, supporting the legalization of assisted suicide.

HB05487 - AN ACT CONCERNING THE SELF-ADMINISTRATION OF LETHAL MEDICATIONS BY TERMINALLY ILL ADULTS.

SB00188 - AN ACT ALLOWING TERMINALLY ILL PATIENTS THE MEDICAL DECISION TO END THEIR LIFE.

Action Alerts will be sent out if any of these bills are scheduled for public hearings.

U.S. CONGRESS

With the Republicans now in control of the U.S. House of Representatives it is less likely that pro-abortion bills will get through Congress. Likewise, with the Democrats still in charge of the Senate, it is unlikely that any pro-life bills will get through Congress. However, Congress still has to pass a budget. That means there likely will be a fight over the Hyde Amendment, which, for decades, has forbidden the use of federal funds for most abortions.

In this post-Roe world, though the votes are not there yet in either house, we may see a renewed effort to begin the process of proposing a Human Life Amendment to the U.S. Constitution.
